## **Grants Risk Management: The Nexus of ERM and Grants Accountability**

Today, buzz words like "enterprise risk management" (ERM) and "accountability" abound in the public and private sectors. But how do they really work operationally? Faced with an \$11 billion budget for grant programs but finite internal resources to manage them, the Health Resources and Services Administration (HRSA) sought a way to use risk management to improve accountability and oversight of grants. Seeking a risk-based, data driven approach to strategic decisions, HRSA embarked on a one-of-a-kind assessment of current risks and related risk management practices, and the development of risk tools for decision makers. This session will provide a case study for operationalizing risk management in the grants world. Those seeking to integrate risk management into their operations will hear about project challenges and successes, key risk findings and recommendations, and considerations when taking on such a project.

#### How Do I Get Started in Managing My Federal Award?

Organizations that receive an influx of funding or are grateful to receive their first government grant can be overwhelmed by the reporting and administrative requirements (including adherence to 2 CFR 200). # **How to Conduct a Control Self-Assessment**

Rather than relying on outside auditors or program monitors, whose findings often come with monetary liabilities, this session will discuss strategies for assessing your own entities' risk of noncompliance, giving you and your staff time to put corrective actions in place before specific costs are questioned.

# **Improper Payments Report Act**

Federal agencies must assure compliant use of grant funds including consequences when nonfederal entities are non-compliant. Policies and procedures that are non-compliant risk consequences, including the loss of awards. Also covered, auditor responsibilities to determine and review improper payments, including examples of Inspector General reports on agency compliance.

#### Improving the Monitoring of Large, Complex Federally Funded Grants and Contracts

This session will present proven techniques used to determine the risks of recipients of federal funds and to monitor and report on subrecipients and contractors.

# Make a Procurement Path: Roadmap to Updated Procurement Levels, Documentation, and Contracts Wendi Gephart, ETR

Keep all your procurement costs allowable by learning, using, and developing organizational policies and procedures designed to document and comply with Uniform Guidance regulations. Attendees will leave with a solid understanding of federal procurement, and sample contracts, policies and procedures to adapt to their specific needs. # Surviving an OIG Audit Your First Day on the Job (True Story)

My first day on the job as a local government's first grants administrator I was tasked with cleaning up a recently completed OIG Audit of a COPS grant. Learn firsthand experience about the fallout from a mismanaged program, how to prove supplanting did not take place, and what to expect throughout the process. With assistance from an involved finance department, each finding was closed and the local government continued to receive federal funding without further restrictions.

### **Technical Assistance Is a Two-Way Street**

Oh no, the auditors are coming! Quite often, the concept of being audited triggers a negative reaction for grants managers. In addition, collaborating with internal audit to incorporate grants-related activities into the annual audit plan and enterprise risk management process may allow your organization to efficiently and effectively monitor subrecipients, maximize revenue, and meet the requirements of 2 CFR Part 200.303, Internal Controls, without requiring additional external resources or operating funding. During this session, we will discuss how internal audit departments have assisted grants managers throughout the country, strategize around approaches to maximize the benefit received during internal audits, and discuss methods of incorporating federal awards into the audit plan without requiring additional unplanned effort and resources.

Attorneys will then moderate a grantee-focused discussion of whether, and how much, to increase the thresholds set forth in internal grantee policies.
